

The policy of using cookies and similar technologies

This policy refers to cookies and similar technologies used, as appropriate, in websites and applications operated by S.C. FORAJ SONDE S.A. headquartered in Craiova, Fratii Buzesti street, no. 4A, Dolj County.

Cookies are used for the following purposes:

- operation of the site and applications,
- analysis of the behavior of the site visitors,
- for advertising.

This policy is complemented by the policy of S.C. FORAJ SONDE S.A. regarding the protection of personal data in general that you can find on the site and which we encourage you to read, these include additional useful information, including the purposes of data processing by S.C. FORAJ SONDE S.A., your rights, as well as their exceptions and limitations, etc.

2. What are cookies?

The cookie is a small file, consisting of letters and numbers, which will be stored on the computer, mobile terminal or other equipment of a user accessing the Internet. The cookie is installed by the request issued by the user's terminal to a Foraj Sonde SA server or to a third-party server.

3. What are cookies used for?

These files make it possible mainly to recognize the user's terminal and to present the content in a relevant way, adapted to the user's preferences.

Cookies provide the users with a pleasant browsing experience and support the efforts of Foraj Sonde SA to offer services more adapted to the users, e.g.: - preferences regarding online confidentiality or relevant advertising. They are also used in the preparation of aggregated anonymous statistics that help us understand how a user benefits from our web pages, allowing us to improve their structure and content, without allowing the user's personal identification.

4. What cookies do we use?

We use two types of cookies: per session and fixed. Cookies per session are temporary files that remain in the user's terminal until the session is terminated or the application is closed. The fixed

cookies remain on the user's terminal for a period determined by the cookie parameters or until they are manually deleted by the user.

5. How are cookies used by this site?

A visit to this site may place the following types of cookies:

- cookies strictly necessary for the functioning of the site
- analysis cookies
- advertising cookies

Cookies and / or similar technologies strictly necessary are essential for the smooth operation of the site, being set on your device when accessing the site or following the actions performed on the site, as the case may be. You can set your browser to block cookies, but in this case certain sections of the site will not work properly.

6. Do cookies or similar technologies contain personal data?

Cookies or similar technologies themselves do not require personal information to be used and, in many cases, do not personally identify Internet users. However, there are situations when personal data can be collected by the use of cookies to facilitate certain functionalities for the user or to provide the user with an experience more adapted to his preferences. Such data is encrypted in a way that makes it impossible for unauthorized persons to access it.

7. Block cookies

If you wish to block cookies, some features of the site will be stopped, and this may cause certain malfunctions or errors in the use of our site. For example, blocking cookies may prevent you from:

- Log in to the protected areas of the applications
- Operate certain data in protected areas

If you agree to these limitations and wish to block cookies, you can do so from the advanced browser settings.

8. Managing cookies placement preferences

In general, an application used to access web pages allows the saving of cookies and / or similar technologies on the terminal by default. These settings can be changed so that the automatic administration of cookies is blocked by the web browser or the user is informed whenever cookies are sent to his terminal.

Detailed information about the possibilities and ways of managing cookies can be found in the

settings area of the application (web browser). Limiting the use of cookies may affect certain functionalities of the website or web applications.

9. Why are cookies and / or similar technologies important for the Internet?

Cookies and / or similar technologies are a central point of the efficient functioning of the Internet, helping to generate a user-friendly browsing experience adapted to the preferences and interests of each user. Refusing or disabling cookies may make some sites or parts of websites impossible to use.

Disabling cookies does not mean that you will no longer receive online advertising, in compliance with the law - but that it will no longer be able to take into account your preferences and interests, highlighted by your browsing behavior.

- Examples of important uses of cookies (which do not require user authentication through an account):
 - Content and services adapted to user preferences - product and service categories.
 - Offers tailored to the interests of the users
 - Password retention
 - Retaining child protection filters on Internet content (family mode options, safe search functions).
 - Limiting the frequency of ad serving - limiting the number of times an ad is displayed for a particular user on a site.
 - Providing user relevant advertising.
 - Measuring, optimizing and adapting analysis features - such as confirming a certain level of traffic on a website, what kind of content is viewed and how a user reaches a website (e.g. through search engines, directly, from other websites, etc.). The websites carry out these analyzes regarding their use to improve their services for the benefit of the users.

10. Security and privacy issues

Generally, browsers have built-in privacy settings that provide different levels of cookie acceptance, validity and automatic deletion after the user has visited a particular site.

Other security aspects related to cookies:

- Customize your browser settings for cookies to reflect a comfortable level for you of the security of the use of cookies.
- If you are the only person using the computer, you can set long deadlines for storing your browsing history and personal access data if you wish.
- If you share computer access, you may consider setting your browser to delete individual browsing data each time you close your browser. This is a way to access websites that place cookies and delete any visit information at the end of your browsing session.
